ambulance services as a permitted or conditionally permitted use in Zones C-H (Commercial Highway), C-1 (Restricted Business), C-2 Neighborhood Business), C-3 (Unlimited Commercial), C-M (Commercial Manufacturing), M-1 (Light Manufacturing), M-1.5 (Restricted Heavy Manufacturing), M-2 (Heavy Manufacturing), and M-3 (Unclassified).

In addition, the Board continued Project No. R2010-01071-(3) an appeal from Regional Planning Commission's approval to August 27, 2013 to allow the applicant to meet legal posting requirements.

Furthermore, Commissioner Louie requested that staff provide a brief memo if there is a conflict between the Los Angeles City Master Plan and the County's Master Plan on the LA River and if we should be addressing it.


