	No yard sales are allowed Monday through Friday.
	I must be able to show proof of registration for any yard sale on a non-designated weekend during the yard sale for inspection purposes.
	I may not sell new, unused or pre-packaged items.
	I may not sell foods or beverages.
	I live at the residence where the yard sale activity is located or I own the property.
	I may have a yard sale on any designated weekend.
	I may only have 2 additional yard sales per year on non-designated weekends, with registration.
	There is an existing residential building (examples: house, duplex, triplex, apartments) on the property where the yard sale is located.
