Tentative Parcel Map No. 071401 ("PM 071401") was considered by Mr. Alex Garcia, a Hearing Officer of Los Angeles County, on November 5, 2013.

After considering the evidence presented, the Hearing Officer in his action on November 5, 2013, **denied** PM 071401 in accordance with Los Angeles County Code ("County Code") Section 21.16.060 (Public Hearings), Section 21.40.110 (Matters Required to Complete Submittal and Filing), and Section 22.56.060 (Denial for Lack of Information). A copy of the denial findings is attached.

**FINDINGS OF THE HEARING OFFICER
COUNTY OF LOS ANGELES
PROJECT NO. 03-106 - (5)
TENTATIVE PARCEL MAP NO. 071401**

1. The Hearing Officer of Los Angeles County, Mr. Alex Garcia, considered Tentative Parcel Map ("PM") No. 071401 on November 5, 2013.
2. PM071401 is a request to create four single-family lots on 79 acres within the A-2-1 (Heavy Agricultural – One Acre Minimum Required Lot Area) Zone. The project site is located on Cedarcroft Road, south of Y-8 in the Soledad Zoned District.
3. The project was filed with the Los Angeles County Department of Regional Planning ("Regional Planning") on April 9, 2003. The Los Angeles County Subdivision Committee last met on October 14, 2010 to discuss the subject project. Holds were placed on the project. The requested materials were never submitted and no activity has occurred on the project since that time. The last time extension for this project granted by the Director of the Los Angeles County Department of Regional Planning expired on October 20, 2011.
4. Since the applicant failed to provide the requested information and/or materials, there is insufficient information to determine the feasibility of the project design, general plan consistency or whether approval of the map would be in the public interest, pursuant to Section 21.40.160 (Advisory Agency Determination Authority) of the Los Angeles County Code ("County Code"). Because of this, the Subdivision Committee is unable to recommend a final action to the Advisory Agency.
5. Staff sent a letter to the applicant dated July 30, 2012 informing the applicant that pursuant to Section 21.16.060 (Public Hearings) and Section 21.40.110 (Matters Required to Complete Submittal and Filing) of the County Code, the case would be scheduled before a Hearing Officer for denial due to inactivity on September 4, 2012.
6. The July 30, 2012 letter also directed the applicant to contact Regional Planning staff within 30 days for the project to remain active. After contacting Regional Planning staff, the applicant was required to provide a revision to the tentative map and/or submit other requested information within 90 days of the date of the July 30, 2012 letter.
7. The applicant submitted a time extension request and was granted a time extension until January 31, 2013 to submit the required materials. The applicant has failed to submit the required materials within the required timeframe, which was by January 31, 2013

8. Staff sent a letter to the applicant dated October 2, 2013 informing the applicant that the case would be scheduled before a Hearing Officer for denial due to inactivity on November 5, 2013.
9. During the November 5, 2013 Hearing Officer public meeting, staff made a brief presentation summarizing the process for denial of a project due to inactivity.
10. During the November 5, 2013 Hearing Officer public meeting, the project applicant was not present. There were no testifiers in support of or in opposition to the project.
11. During the November 5, 2013 Hearing Officer public meeting, the Hearing Officer denied Tentative Parcel Map No. 071401 due to inactivity.

THEREFORE, in view of the findings of fact presented above, Tentative Parcel Map No. 071401 is DENIED.
