Notice is hereby given that the Regional Planning Commission will conduct a public hearing concerning this land use proposal on Wednesday, **April 7, 2010 at 9:00 a.m.** in Room 150, Hall of Records, 320 West Temple Street, Los Angeles, California 90012. Interested persons will be given an opportunity to testify. The hearing room will open at 8:50 a.m.

REQUEST: Conditional use permit to allow the continued operation of a church, a use subject to permit in the A-1-6,000 (Light Agricultural – 6,000 Square Foot Minimum Lot Size) Zone.

LOCATION OF SUBJECT PROPERTY: The subject property is located at 323 Workman Mill Road in the unincorporated community of Avocado Heights and Avocado Heights Zoned District.

This case does not affect the zoning of surrounding property. If you are unable to attend the public hearing but wish to send written comments, please write to the Regional Planning Commission, 320 West Temple Street, Los Angeles, California 90012.

If the final decision on this proposal is challenged in court, testimony may be limited to issues raised at the public hearing or by written correspondence delivered to the Regional Planning Commission at or prior to the public hearing.

This project has been determined to be categorically exempt (Class 1 – Existing Facilities) from the reporting requirements under the California Environmental Quality Act.
