NOTICE OF PUBLIC HEARING

Notice is hereby given that the Hearing Officer will conduct a public hearing concerning this land use proposal on, **Tuesday, July 20, 2010 at 9:00 a.m.** in **Room 150 in the Hall of Records, 320 West Temple Street**, Los Angeles, California 90012. Interested persons will be given an opportunity to testify. The hearing room will open at 8:50 a.m.

REQUEST: The applicant, Sprint, is requesting a conditional use permit to continue the operation and maintenance of an existing unmanned wireless telecommunication facility (WTF) in the Unlimited Commercial – Development Program (C-3-DP) Zone. A telecommunication facility is a use subject to a Conditional Use Permit pursuant to Section 22.40.040 of the Los Angeles County Code.

Section 704 of Title 7 of the Federal Telecommunications Act of 1996 (effective February 8, 1996), contains the following language:

“IV. No State or local government or instrumentality thereof may regulate the placement, construction, and modification of personal wireless service facilities on the basis of the environmental effects of radio frequency emissions to the extent that such facilities comply with the Commission’s regulations concerning such emissions.”

LOCATION OF SUBJECT PROPERTY: The subject property is located at 27200 Agoura Road in the Santa Monica Mountain North Area, within The Malibu Zoned District.

This case does not affect the zoning of surrounding properties. If you are unable to attend the public hearing but wish to send written comments, please write to the Hearing Officer, 320 West Temple Street, Los Angeles, California 90012.

If the final decision on this proposal is challenged in court, testimony may be limited to issues raised at the public hearing or by written correspondence delivered to the Hearing Officer at or prior to the public hearing.

The recommended environmental document for this project is a Categorical Exemption-Class 1, which has been prepared in compliance with the environmental reporting procedures and guidelines under the California Environmental Quality Act (CEQA).
