Notice is hereby given that the Planning Commission will conduct a public hearing concerning this land use proposal on, **Wednesday, April 14, 2010 at 9:00 a.m.** in Room 150, Hall of Records, 320 West Temple Street, Los Angeles, California 90012. Interested persons will be given an opportunity to testify. The hearing room will open at 8:50 a.m.

REQUEST: To authorize a conditional use permit to establish a collection facility for scrap metal and other materials such as cardboard, newspaper and CRV.

LOCATION OF SUBJECT PROPERTY: The subject property is located at **2241 E. 89th Street, Los Angeles** Ca 90002 in the unincorporated community of Florence-Firestone, in the Firestone Park Zoned District.

If the final decision on this proposal is challenged in court, testimony may be limited to issues raised at the public hearing or by written correspondence delivered to the Planning Commission at or prior to the public hearing.

This project has been determined to be categorically exempt Class 3 from the reporting requirements under the California Environmental Quality Act.
