Notice is hereby given that the Regional Planning Commission will conduct a public hearing concerning these land use proposals on Wednesday, July 14, 2010 at 9:00 a.m. in Room 150, Hall of Records, 320 West Temple Street, Los Angeles, California 90012. Interested persons will be given an opportunity to testify. The Negative Declaration associated with this project will also be considered. The hearing room will open at 8:50 a.m.

ENTITLEMENTS REQUESTED:

Conditional Use Permit Requests: To authorize the construction, operation, and maintenance of a wireless telecommunications facility to be mounted on an existing utility pole within the public right-of-way. The project consists of installing two antennas on six-foot extension arm on the existing utility pole at a height of no more than 28 feet. No equipment shelter is proposed. The facility will be connected to an existing power source via a ground rod and conduit trench. The utility pole is located in an Environmental Sensitive Habitat Areas (ESHA) within the Malibu Coastal Zone and is subject to review by the Los Angeles County Environmental Review Board.

LOCATION OF SUBJECT PROPERTIES: In the public right-of-way on Topanga Canyon Blvd, near Castle Top Trail between Mulholland Highway and Pacific Coast Highway, Santa Monica Mountains area.

These cases do not affect the zoning of surrounding properties. If you are unable to attend the public hearing but wish to send written comments, please write to the Planning Commission, 320 West Temple Street, Los Angeles, California 90012. If the final decision on this proposal is challenged in court, testimony may be limited to issues raised at the public hearing or by written correspondence delivered to the Planning Commission at or prior to, the public hearing.

A Draft Negative Declaration has been prepared for this project. The draft environmental document concludes that the project design and/or suggested conditions will adequately mitigate these impacts to a level of no significance. Notice is hereby given that the County of Los Angeles will consider a recommendation to adopt a Negative Declaration.
