If the final decision on this proposal is challenged in court, testimony may be limited to issues raised before or at the public hearing.

**Project Location:** The Unincorporated Santa Monica Mountains Coastal Zone

**Project Description:** Request to amend the Santa Monica Mountains Local Coastal Program (LCP), to correct and update maps contained in the Santa Monica Mountains Land Use Plan (LUP) and Local Implementation Program (LIP), and to make minor text changes to the LUP and LIP, pursuant to section 22.44.700 of the Los Angeles County Code. The California Environmental Quality Act (CEQA) and Sections 30500 through 30522 of the California Public Resources Code provide that the process of preparing an LCP, and amendments thereto, is functionally equivalent to the preparation of an Environmental Impact Report (EIR). As such, the County is not required to prepare a CEQA document for the proposed LCP amendment.
