NOTICE IS HEREBY GIVEN that a public hearing will be held before the Regional Planning Commission to consider the following ordinance amendment on **Wednesday, May 27, 2015**, at 9:00 a.m. in Room 150, Hall of Records, 320 West Temple Street, Los Angeles, California 90012. Interested persons will be given an opportunity to testify. Room 150 will open at 8:50.

Proposal: A Countywide Ordinance amending Title 22 of the County Code (Planning and Zoning) to revise requirements for Animal Facilities. The amendment will allow for the boarding and breeding of cats and dogs as a permitted use in the A-2 and M-1 zones, while requiring a Conditional Use Permit for the use in the C-M zone. New standards will also be created for the A-2 zone to establish minimum lot size requirements for a specific number of cats and dogs allowed in a facility. The amendment will make Regional Planning's requirements consistent with the existing requirements of the Department of Animal Care and Control.

A draft Negative Declaration has been prepared for this project. The draft environmental document concludes that the project and/or suggested conditions will adequately mitigate these impacts to a level of no significance. Notice is hereby given that the County of Los Angeles will consider a recommendation to adopt a Negative Declaration.

Temple St., Los Angeles, CA 90012, con respecto a la siguiente propuesta:

Se propone una enmienda al Título 22 del Código del Condado (Planificación y Zonificación) del Condado de Los Angeles para definir las instalaciones de animales y proporcionar áreas donde se permite el uso, o permite con condiciones. La ordenanza incluye las normas de desarrollo para asegurar la compatibilidad con las propiedades adyacentes.
