This is a follow up to the memo dated November 25, 2014 regarding Item 6, the General Plan Update, for the December 10, 2014 public hearing.

## **ADDITIONAL EDITS/UPDATES**

### **Land Use Policy Maps**

Staff corrected two non-substantive errors found in the draft land use policy maps for North Whittier and Lennox. For North Whittier, half of an existing multifamily property was shown incorrectly as H5. Staff has corrected the map to match with the other half of the property, which is H18. For Lennox, staff added a Caltrans-owned property that had been omitted from the map. The corrected land use policy maps are included as an attachment to this memo. They can also be found on the Department's General Plan Update web page.<sup>1</sup>

### **Appendix E**

Staff also corrected a non-substantive error in Appendix E Conservation and Natural Resources Element Resources to add back in the sources for the Significant Ecological Area descriptions. The revised Appendices, dated December 4, 2014, can be found on the Department's General Plan Update web page.<sup>2</sup>
