# What is the Inglewood Oil Field?

The Inglewood Oil Field encompasses 1,060 acres in Baldwin Hills, producing oil and gas to meet California's energy needs and has been in operation for nearly 100 years. Currently, 54 men and women are employed full-time at the field. In addition, approximately 75 contractors support the operation on an average day.

### Current operations

The Inglewood Oil Field is the largest of Los Angeles Basin's remaining producing urban fields. More than 400 producing wells are active, producing an average of 4,600 barrels of oil and 2.5 million cubic feet of natural gas gross each day. Current operations consist of routine well and facility maintenance as well as ongoing well abandonment. No drilling/re-drilling activities are currently planned for the Year 2021. The Park to Playa Trail is open. This community access path goes through the Inglewood Field.

#### Plans for 2022

No new wells have been drilled since 2014. There are no plans to drill new wells in 2022. SPR annually provides a list of well candidates should conditions change.

Similar to prior years, the re-work of some existing wells is scheduled throughout the year to maintain production along with other repair and maintenance activities. No major work is planned in 2022 for tankage or other supporting facilities. Twelve wells are scheduled to be plugged and abandoned (P&A) in 2021. As of August 1st, five have been P&A'd. Twelve wells are also scheduled to be P&A'd in 2022.
