CERTIFIED BIOLOGICAL CONSULTANT APPLICATION

This application is for biological consultants who are seeking to provide environmental services, such as the creation of biological inventories, reports, and maps which require review by the Environmental Review Board (ERB), the Significant Ecological Areas Technical Advisory Committee (SEATAC), and/or as otherwise required by the Los Angeles County Code. Project applicants will contract directly with the biological consultant and submit the necessary biological reports to the Los Angeles County Department of Regional Planning.

Two certification tiers are offered:

- Tier 1 preparation and submittals restricted to biological maps.
- Tier 2 preparation and submittal of all types of biological reports. Tier 2 is inclusive of Tier 1.

APPLICATION MATERIALS

Tier 1 application, submit 1 and 3 below. Tier 2 application, submit 1 through 3.

- 1. Resume with the following information:
 - Applicant's name, associated firm (if any), and title;
 - Address, telephone, email;
 - Education, work experience, and relevant publications, certifications, etc.;
 - Emphasis of work experience with regard to preparation of biological reports.
- 2. Sample Biological Report. A work sample that addresses similar topics to those required in the Biological Reports Checklist that demonstrates a high level of biological impact and complexity. The work sample should include an inventory of resources (plants and/or animals), complex analysis of impacts to the resources, and mitigation recommendations. Submit a link to the document if is larger than 20 MB.
 - The work sample should preferably be of an unincorporated area of Los Angeles County, but not mandatory. It should include a description of your role in its development (such as primary author, contributor, reviewer, technical assistant, etc.).
 - The work sample should show analysis of field data and demonstrate the applicant's authorship. In the case of a work sample prepared by a consulting company with input from several specialists, the applicant's cover letter should clarify which parts of the report demonstrate the applicant's analysis of field data and authorship if it is not clear in the report.
 - In particular, the work sample needs to show:
 - a. An analysis of biological resources and impacts like those described for biological reports in the Significant Ecological Area and Santa Monica Mountains Local Implementation Plan (SMM LIP).
 - b. Treatment of both plants and all manner of animals (especially vertebrates) with reference to the California Natural Diversity Database and the California Natural Diversity Database lists, with evaluation of potential of all species in those lists to be affected by the project.
 - c. Consideration of impacts and recommendations for mitigation of impacts.
- 3. Sample Biological Constraints Map prepared as outlined within the SEA Implementation Guide Chapter 6 (found here). The sample may be from previous work or prepared purposely for this application.
