
COMMUNITY ALERT NOTIFICATION SYSTEM TEST 2023

The Inglewood Oil Field is the largest urban oil field in California. This designation comes with increased responsibilities to the surrounding community in the event of an emergency. Sentinel Peak Resources, the operator of the Inglewood Oil Field, currently contracts with CodeRED to facilitate a Community Alert Notification (CAN) system to aid in communicating with our neighbors should an emergency arise. This system is intended to enable the operator to effectively and swiftly contact residents and businesses adjacent to the oil field should an emergency event take place on our property mandating evacuation, taking shelter or other protective actions. Any alert would be sent out in conjunction with local emergency management departments. The Baldwin Hills Community Standards District requires the operator of the Inglewood Oil Field to conduct a test of the CAN system each year. Below are the 2023 test results as conducted by Sentinel Peak Resources.

The test notification contact group for this year's exercise consisted of 36 contacts including Sentinel Peak Resources Employees, local fire and sheriff stations and CAP members.
