## 2. Hearing on Annexation and Levying of Assessments for County Lighting Districts in the Unincorporated Area of Azusa

Hearing on annexation of Petition No. 56-1017 within the unincorporated area of Azusa (1) to County Lighting Maintenance District (CLMD) 1687 and County Lighting District Landscaping and Lighting Act-1 (CLD LLA-1), Unincorporated Zone; order changes to the Engineer's Report, if needed; order the tabulation of assessment ballots submitted and not withdrawn, in support of or in opposition to the proposed assessments, and if there is no majority protest, adopt a resolution ordering the annexation of territory to CLMD 1687 and CLD LLA-1, Unincorporated Zone, confirming a diagram and assessment and levying of assessments within the annexed territory for Fiscal Year 2025-26; and adopt joint resolutions between the Board and other taxing agencies approving and accepting the negotiated exchange of property tax revenues resulting from the annexation of territory to CLMD 1687, as approved by the nonexempt taxing agencies. **(Department of Public Works)** (23-4009)

The Department of Public Works submitted a written statement for the record.

All persons wishing to testify were sworn in by the Interim Executive Officer of the Board. Opportunity was given for interested persons to address the Board. Eric Preven addressed the Board. No correspondence was received.

Adopted a resolution ordering annexation of territory to CLMD 1687 and CLD LLA-1, Unincorporated Zone, confirming a diagram and assessment and levying of assessments within the annexed territory for Fiscal Year (FY) 2025-26, with the adoption of the resolution ordering annexation to constitute the levying of assessments in FY 2025-26; and
- 4. Adopted joint resolutions between the Board and other taxing agencies approving and accepting the negotiated exchange of property tax revenues resulting from the annexation of territory to CLMD 1687 as approved by the nonexempt taxing agencies.

## 4. Hearing on Ordinance Amending County Code, Title 8 - Consumer Protection, Business and Wage Regulations

Revised hearing on ordinance for introduction amending County Code, Title 8 -Consumer Protection, Business and Wage Regulations, adding Chapter 8.42 -Sidewalk Vending, to regulate Sidewalk Vendors in the County Unincorporated Areas (All Districts); defines "Sidewalk Vendor" as a regulated business activity on sidewalks and pedestrian paths in the Unincorporated areas; creates administrative procedures for a Sidewalk Vendor program; requires that a Sidewalk Vendor register each year and pay an annual fee of \$604, as recommended by the Auditor-Controller for the reasonable regulatory costs for issuing the registration certificates and enforcing Chapter 8.42, with the fee amount subsidized by the Department of Economic Opportunity and the fee amount reduced to \$0 in the first year of the program; regulates the operations of Sidewalk Vendors, including distancing and equipment requirements to ensure public health, safety, and welfare; prohibits tables and chairs for customer use on sidewalks and pedestrian paths pursuant to State and Federal accessibility standards; and establishes an enforcement and appeals process, including imposition of fines and penalties for noncompliance. (Department of Economic **Opportunity** (Continued from the meeting of 12-12-23) (23-4317)

- 2. Authorized the Director of Economic Opportunity to reinvest the fines and penalties collected through this Chapter into the Sidewalk Vending Program; and
- 3. Made a finding that the proposed actions are not a project under the California Environmental Quality Act.

## 5. Hearing on a Resolution to Increase the Developer Fee for the Consolidated Fire Protection District

Hearing on adoption of a resolution, acting as the Governing Body of the Consolidated Fire Protection District (District), to increase the 2023 Developer Fee Program rates for the Area of Benefit 1, Malibu/Santa Monica Mountains/City of Calabasas, to \$1.1756 (+\$0.0411) per sq ft; Area of Benefit 2, Santa Clarita Valley, to \$1.6176 (+\$0.0677) per sq ft; and Area of Benefit 3, Antelope Valley, to \$1.1280 (+\$0.0399) per sq ft (3 and 5), effective April 1, 2024; and find that updating the Developer Fee Program is exempt from the California Environmental Quality Act. ## 7. Hearing on Project No. 2020-000612-(1 and 5), East San Gabriel Valley Area Plan Project

Hearing on Project No. 2020-000612-(1 and 5), Advance Planning Case No. RPPL2021013047-(1 and 5), General Plan Amendment No. RPPL2022003554-(1 and 5), Zone Change No. RPPL2022003557-(1 and 5), Ordinance No. RPPL2022014158-(1 and 5), Environmental Assessment No. RPPL2022003550-(1 and 5), to approve the East San Gabriel Valley Area Plan (ESGVAP) and associated documents collectively known as the Project, including amendments to the General Plan and its accompanying Land Use Policy Map, amendments to County Code, Title 22 - Planning and Zoning, including the zoning map, rescission of the Rowland Heights and Hacienda Heights Community Plans and their incorporation into the ESGVAP, and the addition of the -GZ suffix to existing Green Zone parcels to facilitate their identification; the ESGVAP is a component of the General Plan that guides development through goals, policies, and implementation actions in 24 unincorporated communities within the East San Gabriel Valley Planning Area (Planning Area) for the next two decades, and the Project redesignates land use and zoning categories, including properties identified in the Housing Element Rezoning Program; the implementation ordinance consists of amendments to County Code, Title 22 - Planning and Zoning, to establish the East San Gabriel Valley Planning Area Standards District, which incorporates and updates the existing Rowland Heights and Avocado Heights Community Standards Districts, establishes new areawide standards, including building height limits and the protection of biological resources and designated significant ridgelines, incorporates four equestrian districts within the Planning Area and consolidates Trailside Ranch and Avocado Heights Equestrian Districts, and incorporates the Southwest Puente Setback District, as a lead agency under the California Environmental Quality Act, the Board will consider the effects of the Project as shown in the Final Programmatic Environmental Impact Report (PEIR), will consider certification of the Final PEIR, and will consider adoption of the associated Findings of Fact and Statement of Overriding Considerations, and Mitigation Monitoring and Reporting Program. (On August 9, 2023, the Regional Planning Commission recommended approval of this Project.) (Department of Regional Planning) (24-0019)

Hearing on Project No. PRJ2021-004165-(All Districts), General Plan Amendment No. RPPL2021011925-(All Districts), Zone Change No. RPPL2021011985-(1, 2 and 4), Advance Planning Project No. RPPL2021011918-(All Districts), Advance Planning Project No. RPPL2022010129-(2), Advance Planning Project No. RPPL2022010131-(1), Advance Planning Project No. RPPL2022010133-(2), Advance Planning Project No. RPPL2022010143-(2), Environmental Assessment No. RPPL2021011920-(All Districts), to approve the Metro Area Plan (MAP) and the associated amendments to the General Plan, County Code, Title 22 - Planning and Zoning, including the zoning map, the Florence-Firestone Transit Oriented District (TOD) Specific Plan, the East Los Angeles Third Street Specific Plan Form-Based Code, the Willowbrook TOD Specific Plan, and Connect Southwest LA: A TOD Specific Plan for West Athens-Westmont, collectively known as the Project, where the MAP is a component of the General Plan that guides development in the seven unincorporated communities within the Metro Planning Area (Planning Area) - East Los Angeles, East Rancho Dominguez, Florence-Firestone, Walnut Park, West Athens-Westmont, West Rancho Dominguez-Victoria, and Willowbrook - over the next 15 years; including the following: (On September 13, 2023, the Regional Planning Commission recommended approval of this Project.) (Department of Regional Planning)

Rescindment of the East Los Angeles Community Plan, the Florence-Firestone Community Plan, the Walnut Park Neighborhood Plan, and the West Athens-Westmont Community Plan;

Redesignation of land use and zoning categories for 848 properties in the Planning Area as identified in the Revised County of Los Angeles Housing Element 2021-29 Rezoning Program and amendments to the zoning map to add the -GZ Combining Zone on industrially-zoned parcels that are subject to existing Green Zones regulations;

Amendments to County Code, Title 22 - Planning and Zoning, to establish the Metro Planning Area Standards District, under which similar development standards in existing Community Standards Districts are combined or consolidated into a single set of Metro Planning Area-wide regulations, to allow the establishment of accessory commercial units (ACUs) and the continued operation of certain nonconforming small businesses in the residential zones in the Planning Area, to allow shared kitchen complexes in certain commercial and industrial zones Countywide, to require a Conditional Use Permit for K-12 schools in certain zones in the Planning Area to address community concerns over traffic congestion around schools, and to require housing developments on certain parcels in the Planning Area to provide an affordable housing set-aside, per State law; Amendments to the four existing TOD Specific Plans to maintain consistency in how uses such as ACUs, shared kitchen complexes, and K-12 schools are regulated across all communities in the Planning Area; and

Reorganization of the Connect Southwest LA and Willowbrook TOD Specific Plans to incorporate regulations and development standards into County Code, Title 22 - Planning and Zoning, while other non-regulatory information remains in the separate Specific Plan documents outside of Title 22.

As lead agency under the California Environmental Quality Act, the Board will consider the effects of the Project as shown in the Final Programmatic Environmental Impact Report (PEIR), will consider certification of the Final PEIR, and will consider adoption of the associated Findings of Fact and Statement of Overriding Considerations, and Mitigation Monitoring and Reporting Program.
