CEQA Determination: Addendum to Mitigated Negative Declaration

Project Description: Surface Mining Permit (SMP) No. 201300002 to amend the Reclamation Plan for SMP No. 00-21 for the existing Acton Clay Quarries in the W (Watershed) Zone. The amendment requests the following changes: 1.) Extend the SMP expiration date to December 31, 2029, consistent with the United States Forest Service Plan of Operations (POO) for the project; 2.) Allow for a maximum of five acres of open excavation in each of the two quarries (10 acres total), consistent with the POO; and 3.) Allow a land swap of three acres of undisturbed land at the Gray Quarry for an adjacent three acres of undisturbed land.
